As per revised Order dated 2/02/2011, dated: 07-05-2020 Deputy Director (Administration), Department of Public Education, Bangalore Rural District. converting classes from Kannada to English medium from 01 to 05 has also been considered.

As per this office letter no.C1. Manayathe, 145/2019-20 date: 07-01-2020 the legalisation of recognition has also been considered for one section of kannada medium per class from 01st to 5th standard from the academic year 2019-2020. As per this office letter no.C1, Manayathe, 145/2019-20 date: 07-01-2020 the legalisation of recognition has also been considered for one section of english medium per class from 01st to 5th standard from the academic year 2019-2020.

Secretary to the Department of Education, Ministry of Education, Government of Karnataka Circular No. E.D.113 Vivida.2005, Date: 02-11-2006, considering all the Circuit and instructions, that too the direction in condition 1 submitted

in the proposal for implementation of the instructions and after considering all the documents in the proposal and on the basis of report of inspection on 10-02-2021, this school recognition without aid with the provision in order to fulfil the below said conditions under Karnataka Education Act 1983 Section 36(6) (b) Recognition Regulations Under the provisions of Sections and Rules of 1999 and the Department of Education of the Subordinate Secretaries of the Government (Pre University Education) Letter No.Ep.46.S.H.S.2020., in the letter dated 10-03-2021, the aided and unaided school existing before 2017-18 has been subsidized from submitting the Fire Safety Certificate and building safety certificate at the time of renewal and considering the previous year documents it has been updated as follows. This Certificate is recognised under following conditions

1. Karnataka Education Act 1983 Karnataka act 1 the rules of 1995 and the circulars and orders issued from time to time by the government and department must be strictly followed.

2. Karnataka Educational Institutions, Classification, Regulation and text book Regulations 1995 Government Notification No: 116 Vivida 95 Date: 14-11-95 as per Regulation 4, 5, 6 and 8 the school must have State curriculum, School Safety and Basic amenities.

According to Karnataka Education Act 1983 Karnataka Act 1 Of 1995 of Karnataka Institutes of Education, Classification, Regulation and Text book Regulations 1995 Government Notification No: ED 116 Vivida 95 Pater 14-11-95 as of Rule 10 and the fee shall only cover special development fees and shall be in accordance with Rule 19 (1).

- 4. According Section 41 (5) of the Karnataka Education Act 1983 provides that the school shall be held in the sanctioned medium and in the same place. School relocation and extradition shall not be allowed for 5 years after the sanction. Generally only one move is allowed. If the relocation is to be handed over after this period, you will have to register the new location.
- 5. As per the Karnataka State Association Registration Act 21 1960 No. 9 of 1957 Act 13 must be filed audit report (as on 31st March) with the Registrar of Societies and the documents must be submitted and the executive committee members of the organization must get approved and reserve approval list for acceptance.
- 6. As per Education Act 1983 Government Notification ED 131 Vivida 98 Dated: 04-11-99 recognition Rule 1999 Rule 3 Subsection 2 and Director of Secondary Education Circular No: C8 (4) (7) sha.shi.A ni.A/01/02-03 dated13-12-02 the Fixed Deposits shall be maintained and renewed from time to time in the joint name of the Secretary to the organistation and the respective Authorized Authorities.
- 7. As per GOVERNMENT ORDER NO: ED 44 SLB 2007 Dated: 03-09-2007 the checklist in Appendix 3, all information, documents must be kept and strictly complied with.
- 8. As per the instructions in Government Notification Number: ED 74 Vivida 2004 Bangalore Date: 14-08-2006, accounts and records should be maintained.
- 9. Government Order No. ED 28 PGC 1994 Bangalore Date: 29-04-1994, Government Circular No. ED 165 PGC 2004 Date: 03-01-2005, Commissioner Circular No. C7 (7) Pra.shi.a / Other / 57 / 2002-03: date 12-02-2004 and 10-02-2005 and C7 (3) Pra.shi.a / Registration-132 / 2005-06 date: 08-03-2006 and Government Order No. ED 28 PGC 94 Bangalore Date: 29-04-1994 and 30-05 -2005, Govt. Order No: ED 1001 DGO 79 Bangalore, Date: 07-08-2000 has been mandated to comply with the language policy.
- 10.As per the instructions of Government Order No. ED 113 SES 2005 Bangalore, dated 20th March 2005 the infrastructure, teacher recruitment and all other facilities in accordance with sections should be provided.
- 11. The teachers must be appointment as per departmental regulations. Teachers who are not qualified as per rules, should be dismissed immediately and qualified teachers must be recruited.
- 12. For every teaching and non-teaching staff recruited in the school, as per the government notification number ED.104 S.E.Pe 2005 date 12-01-2006. The service details and service entries must be maintained from time to time as per the instructions.

- conditions reported in the report? Every teaching and non-teaching staff recruited in the school must be provided with service security as per government order dated 12.01.2006.
- 14.If the institution has been transferred and the school has been moved since its inception, than the school must obtain a new registration and new recognition and must be renewed from time to time in accordance with the Education Act.
- 15. In accordance with the instructions of Commissioner of Police, Bangalore City, Order No: 157 / MAG (1) Other / 2014 Date: 26-07-2014, the Commissioner of Police in the view of safety of children in school, has passed guidelines with 09 aspects, the school governing bodies should follow all security measures in accordance with the regulations.
- 16. All security measures shall be taken in accordance with the regulations.
- 17. The school must be registered under R.T.E act
- 18. No corporal punishment should be given to school children.
- 19. Take precautionary measures to free the school building from fire and electrical hazards and incorporate fire extinguishers and follow the directions given in Supreme Court Case No-483/04 dated 13/04/2009.
- 20. A smoking cessation notice board must be placed within 200 meters of the school.
- 21. After the enactment of the Right to Education Act 1983, the existing schools are compulsory and must be registered.
- 22. According to Education Coordinator report very low enrollment / attendance is reported. In the next academic year, the enrolment and attendance must be increased, if missed, the order is automatically cancelled.
- 23. The maintenance of school vehicles shall be complied with the instructions in respect of the Department of Transportation.
- 24. The stairs to the upper floors of the school should not be narrow. If there is no safe wall or very small walls at each level, caution should be exercised. At the very least, there should be 5 foot barrier walls. Grills should be installed so that the air lighting system does not interrupt. This recognition applies only if all of the following conditions are met. If missed, it will be cancelled,
- 25. Teachers must pass the Teacher Eligibility Test (TET) test to teach children in grades 1 to 5. (Effective from 09-06-2014) The Board of Management shall appoint only teachers who have passed the examination.
